Special Pricing and Terms Agreement “B” Residential Reverse Osmosis System

New application.

Upgrade application I am currently enrolled in the SP&TA “A”. **or Preferred Customer program.** To avoid duplicate charges please upgrade that agreement now.

According to the terms and conditions set forth herein, **UltraSafe Water Source™** (hereinafter called the company) on its approval of this application, agrees to rent to the undersigned customer/representative, (hereinafter called the customer) and the customer agrees to rent from the company, residential Reverse Osmosis equipment (hereinafter called the equipment) installed in the customer’s residence.

1. The undersigned customer agrees that the water purification system rented under this agreement is only for personal use by residents of his or her residential household. It is further agreed that the equipment so rented is not for commercial use or for resale.
2. The customer acknowledges that the equipment installed according to this agreement shall at all times remain the property of the company and further agrees that any nameplates, tags or other identification on the equipment shall remain in place and not otherwise be altered in any way by the customer.
3. The customer hereby acknowledges that untreated water quality may vary considerably from place to place. Accordingly, the customer agrees to pay for all water analysis that may be required by the company. Based on the results of such an analysis, the company shall make such recommendations as may be necessary to the customer regarding the requirement of ancillary equipment that may be necessary for the proper operation of the equipment, such as, but not limited to booster pump, water softening equipment, or iron removal equipment. The company reserves the right to refuse the installation of Reverse Osmosis Equipment, if in its sole discretion, the input water quality is insufficient, or the credit worthiness of the applicant is questionable.
4. The customer hereby acknowledges that filters are a disposable wear item and assumes the cost of their replacement. All replacement filters must be purchased from the company.
5. The term of this agreement shall be one month, and subject to Clause 7, automatically renewing from month to month.
6. The equipment shall remain as personal or movable property and as such shall be removable regardless of the manner in which it may be attached or secured to any real estate. The customer hereby agrees not to modify the equipment in any way and further agrees not to attach any accessories or attachments to the equipment without the express written consent of the company.
7. In the event of loss of, theft of, or damage to the equipment, or its removal without the expressed written consent of the company, the customer shall pay to the company the replacement value of the equipment or at the company’s discretion, the full cost of repairs necessary to return the equipment to full serviceable condition.
8. Force Majeure. The company undertakes to service and maintain the equipment in serviceable condition within reasonable dispatch. Any circumstance that is beyond the company’s control shall be interpreted so as to save the company harmless for any loss or inconvenience to the customer.
9. If the premises of the customer shall at any time be seized, or taken in an execution or attachment by any creditor, or if the customer fails to pay the fees due hereunder, or if the customer shall make any assignment for the benefit of his or her creditors or becomes bankrupt or insolvent, then the customer shall be considered to be in default under this agreement and this agreement shall immediately become null and void and the customer hereby gives full lawful consent and leave to the company to enter the premises in which the equipment is situated, and remove same.
10. **In the event that the customer intends to move from the present domicile wherein the equipment is installed, he or she shall notify the company giving a minimum of one month’s notice of the intended move and in such notice request that the company either terminate this agreement and remove the equipment, or move the equipment at the customer’s expense, to the new place of residence. In the event that the aforesaid notice is not executed by the customer, and the equipment is in any way abandoned, then the customer hereby acknowledges indebtedness to the company for all expenses incurred in locating, collecting and refurbishing such equipment.**
11. The company reserves the right to modify withhold or terminate this agreement at any time for any reason.
12. The company will not issue credit to the customer, and so the customer agrees to retain on deposit with the company sufficient funds to cover his/her purchases. To initiate and maintain this agreement a deposit of \$35.00 is considered sufficient. (\$45.00 for unit c/w booster pump)
13. In the event that the customer wishes to terminate this agreement he/she shall notify the company in writing giving a minimum of thirty days notice. Such termination shall become effective on the last monthly anniversary date of this agreement to which deposit monies may be sufficient.
